## Non-profit Sector Priorities for Election 2017

On Saturday 23 September our country will go to the polls to elect a new government. The lead-up to that will see lots of debate and competing claims from the candidates about what policies we need for social equity and community wellbeing. Our sector will also want to see policies for a thriving sector.

From now until the election, SEWN will be featuring the views of non-profit organisations about topics they would like to see on the election agenda. We would also love to hear from you about what your organisation sees as top priorities to get in front of candidates and political parties (email [sharon@sewn.org.nz](mailto:sharon@sewn.org.nz) or ph 366 2050). The more voices we have, the more chance we have to get our goals addressed.

### Crisis? What crisis?

Campaigners for better mental health services are disappointed that the Prime Minister says there is no need for a review of the mental health system. This has come after the recent release of the "[People's Mental Health Report](#)" that identified issues and made four recommendations:

- An urgent funding increase for acute and community-based services;
- Fully independent oversight of the mental health system;
- An urgent independent inquiry into the structure and provision of mental health services;
- A national education programme to help NZers understand what mental health is and what services are available.

The PM has promised more funding, but commentators say that an inquiry is needed to ensure that the mental health system is configured in the right way and the funding is spent in the right places. As Platform Trust says, "The recent People's Mental Health Report was initiated out of a shared sense of frustration and the completed review report is an excellent and moving companion to the ever-growing mountain of evidence of system failure." Certainly, the volume of stories and reports that a basic google search comes up with justifies the descriptions of crisis in the mental health system that goes beyond simply resourcing.

On top of this nation-wide crisis, the impact of the earthquakes on mental health is now peaking and mental health services in post-quake Canterbury are stretched beyond capacity. See article [HERE](#)

Yes, we need funding, and the promised increase is greatly appreciated. Most importantly though, we need to make sure that funding is going to where it will make most difference.

# There's An Election Coming Up. What Sort of Democracy Do We Want?

News that Forest and Bird, one of New Zealand's largest and most respected conservation organisations has quit the Land and Water Forum comes as no surprise. (Dominion Post, 8 March 2017)

The forum is described as "a Government-led body which brings together dozens of environmental, industry and recreational groups to improve freshwater management." Forest and Bird (F&B) was one of its earliest members. F&B President Mark Hanger said "The forum provided the Government with consensus recommendations that had buy-in from all the relevant stakeholders, incorporating the best scientific advice, yet they've come up with something very different. In putting the forum's recommendations to one side, the Government has undermined the good faith and trust that we put in the forum to help address the freshwater crisis facing New Zealanders"

We are dealing with a 3<sup>rd</sup>-term Government that is following the pattern of previous 3<sup>rd</sup>-term Governments – a growing arrogance in their role as decision-makers, leading to increasing isolation from real communities. It seems deeply embedded in our culture that we vote every 3 years to elect people to make decisions on our behalf, and then many of us just hope they'll just get on and do it – we will only get involved if they do something that really upsets us, like "meddle with our Super".

I think we, as New Zealanders, need to evolve our democracy to make it more participative, and I believe that in the community and voluntary sector we have skills and experience that can contribute to much better decision-making by government and its agencies. Every Government agency I work with seems to run on an assumption that participative decision-making is too hard, or expensive, and is somehow unconstitutional. As for the September election, what can community groups do?

I'd suggest, invite candidates of every party to come and meet you, tell them what you do, tell them how it makes a difference in the community, and tell them how you can help government work better for your people and your community. And then, in your newsletters, website, Facebook, wherever, encourage your members or participants to go and vote. Don't tell them who to vote for (you could lose your charity status) but you are allowed to report on how the different candidates responded to your ideas.

Go for it – Please. Our democracy needs you!

## Sector meeting with Poto Williams

Labour MP Poto Williams recently met with non-profit sector people to talk about policy for the sector. The meeting covered a great range of topics, including contracting, our relationship with government, and the extent to which the sector is valued and respected.

SEWN supported the call for the requirement for identifying client data to be scrapped, and for a different approach to government management. We also agreed with others at the meeting who appreciated the good relationship they had with most local staff of government departments. The efforts that those staff made to support the sector was appreciated.

We raised our concern that government focuses on only that part of the sector that has service contracts with government, while the far greater part of the sector that builds community resilience and social capital through participation is all but invisible to it. We want to see government recognise and value the contribution that *all* of the sector makes to building community wellbeing.

We also spoke about our concern that ministries are accountable to their ministers only for the direct outcomes they are required to deliver. For instance, the Ministry of Education is accountable to the Minister of Education only for education outcomes, and was not accountable for the social or community impact of school closures after the earthquakes.

Finally, we also called for an end to the tired old claim of 'too many groups' and calls for amalgamations. We know that community groups are an essential part of building social capital, but nobody knows

how many groups are needed for optimal social and community wellbeing. How then do we know that we have too many groups?

## Get ready to vote in the 2017 General Election

Everyone has a different reason for voting – whatever you're in it for, the Enrolment Commission wants to help you have your say on who runs the country. Enrol or update your details now to make sure you're ready to vote in the 2017 General Election on Saturday 23 September.

You must enrol if you are 18 or over, a New Zealand citizen or permanent resident, and have lived in New Zealand continuously for one year more at some time in your life.

It's easy to enrol. To get an enrolment form, go online at [www.elections.org.nz](http://www.elections.org.nz), call 0800 36 76 56, pop into a Post Shop or text your name and address to 3676.

*If you believe that having your details made publicly available on the electoral roll could threaten your personal safety, or that of your family, you may be eligible to go on the unpublished electoral roll. Your enrolment details would be held securely by the Registrar of Electors in your local area, would not be released to anyone, and would not appear on the published roll.*

## Volunteers through the generations: how are they different?

Recently, Taylah Mawson and Liyana Azul from Student Volunteer Army (SVA) spoke about the excellent programmes that they're running:

- Schools programme involving year 12s and year 10s across 11 high schools, trying to promote volunteering in young minds
- Big Give – large scale project to help a struggling community – recently in South Brighton, 800 volunteers, great feedback from the community and volunteers.
- City Care connect – another big community project, later in 2017 in Linwood
- Camps – recent camp at Hamner Springs
- Frequent weekend projects

They also touched on the motivation for students to volunteer – project based, being able to see a visible end goal, plenty of 'warm and fuzzy' moments, and food, food, food! Liyana also ventured that volunteering as a new migrant had led to strong connectedness to a new location. <http://www.sva.org.nz/>

### Serve for New Zealand

Eileen Hennessey from Serve for New Zealand spoke about the background and ethos of Serve for NZ on Anzac Day, and encouraged us to participate in pledging hours to help in this country-wide project to promote volunteering across New Zealand. <http://servefor.nz/>

**Group discussion** The meeting touched on the problems of reducing volunteer hours; the Volunteering New Zealand survey 2016 suggested volunteering hours have dropped by a huge 42%, and regular long-term volunteers not being as available to some organisations.

Cath Ford, Girl Guiding NZ, struck a chord with her observation that volunteer management used to be about the organisation, whereas now it needs to be more about the volunteer – how can we manage the individual volunteer to provide the flexibility they want or need.

This led to discussion of promoting more skills-based volunteering and subsequent training. This led to another difficult problem - people can leave after training and it becomes hard for organisations to deal with. Unfortunately organisations might simply have to factor in that people may leave after they've been

trained. One organisation we've spoken to offers 3 month roles, even though they are wanting long term volunteers – they then have the challenge of motivating, training and retaining their volunteers so that they remain part of the organisation, or if they leave after 3 months they return at a later date.

There was discussion at the meeting on what drives different generations, and generalising, we discussed Millennials enjoying project-based work with an end goal, Generation Xers driven by direct feedback of their performance, Baby-Boomers working for, and believing in, the organisation, and the older generation enjoying volunteering more as a social activity. Obviously these are generalisations, but this might impact management styles for different individuals. And on recruitment there's still a place for encouraging volunteers, for shoulder tapping people and giving them the confidence to volunteer. We also picked up on an idea from the Student Volunteer Army of getting more in depth feedback from our volunteers – what do they want, what is going well?

### **Summary**

Volunteering now is less about the organisation, and should be thought of more about the volunteer. Flexibility in approach and what volunteering offers is key to successfully managing our volunteers.

## **Post Disaster City Research**

Raven Cretney (RMIT University of Melbourne) has been putting the final touches to her thesis resulting from a Post Disaster City Research project in which over one hundred people participated and their stories, experiences and opinions were integral to recording what has happened throughout the recovery from the earthquakes.

Rachel has also tried to share the wider stories and findings to communicate the incredible achievements of community led recovery in Christchurch as well as the challenges and lessons that have emerged, particularly from the formal government processes of participation and engagement.

## **Ministry for Women Releases New Gender Pay Gap Research**

The national gender pay gap is now 12 percent and appears to have stalled over the last decade.

In early March, the Ministry for Women released 'Empirical Evidence of the Gender Pay Gap,' a research report it had commissioned Auckland University of Technology to undertake.

That research, the first into the gender pay gap in New Zealand in more than a decade, showed there is a difference in the earnings of men and women that can't be explained by differences in education, occupation and industry, or part-time work.



These factors, commonly cited as causing the gender pay gap, only explain 20 percent of the gap. "Most of the gender pay gap—80 percent in fact—is caused by factors like unconscious and conscious bias that

impacts negatively on women's recruitment and pay advancement," says Margaret Retter, Acting Chief Executive of the Ministry for Women.

"Women are now more highly qualified than men on average," adds Margaret, "This level of increased qualifications should be reducing the gender pay gap. However, the research shows that these qualifications are not fully reflected in women's earnings. For women on lower incomes, factors such as type of work, family responsibilities, education, and age remain important.

The Government is working to increase women's participation in high-demand occupations and to address pay equity (undervaluation of female dominated occupations). This should help reduce the gender pay gap for groups of women on lower incomes, including Māori, Pacific, migrant, and sole mothers. For women on higher incomes, the focus now needs to be on addressing assumptions about women in work, including unconscious bias. This is particularly important for people who make decisions about attracting, recruiting, retaining, and promoting staff.

Ever wondered which tools super-productive and uber-organised people use to get things done? Here are some great ideas for computer programmes/apps from Bizdojo to make your life easier!

### Top 10 Tools:

1. **Canva.com** Quick image for social media/logo/brochure Cost: Free, some stock photos \$1
2. **Dropbox.com** Free cloud based document storage and back up Cost: Free (limited uploads). Up-graded storage \$99 USD per month
3. **G Suite for non-profits** Google's non-profits programme giving free access to a number of Google's paid products, tools and non-profit services. Cost: Free. [TechSoup New Zealand](http://TechSoup New Zealand) validate New Zealand charities for Google. If you haven't heard of Techsoup and the free or heavily discounted software and hardware perks they offer, visit their website.
4. **Last Pass:** Password manager, only ever remember one Master password! Cost: Free for individuals. Enterprise accounts available too, and they offer a 30% discount for non-profits.
5. **MailChimp.com** Send out email newsletter updates and more. It's simple to use, offers beautiful templates, and tells me how things are performing. The paid version also lets you set up automated emails Cost: If you have less than 2,000 subscribers, it's free to use. You can also easily integrate a sign-up form on your website. They offer a [15% discount to charities](#).
6. **Asana.com** Web and mobile application designed to help teams track their work, everything from strategic plans to content calendars. Plus, you can turn on a cute message that gives you high-fives as you tick off your tasks too! Cost: Free to use for teams of up to fifteen people. It offers a discount to small teams of less than forty people.
7. **Xero.com** A Kiwi-made finance package that's so easy to use. From filing expense claims on the go to reconciling accounts. [Xero](#) phone app too. Cost: \$55 a month. 25% discount for charities.
8. **Squarespace:** Think of [Squarespace](#) as your very own IT department, with free, unlimited hosting, top-of-the-line security, an enterprise-grade infrastructure, and around-the-clock support". It seamlessly integrates with social media, MailChimp Cost: USD \$12 to \$40 per month depending on your needs - this includes your hosting costs too. If you already have a domain, you can connect it easily.
9. **Slack** Offers real-time messaging and topic channels, designed with team chat in mind, and as a result it often replaces internal emails, which leads to less cluttered emails! You can share documents and ideas with each other in Slack too, it's the perfect place to collaborate and get feedback Cost: Free to charities for any number of users.
10. **Zapier** Lets you easily integrate the apps that you use. It's a tool primarily for non-technical users to connect web apps together – apps like many of the ones listed here including Xero, Gmail, Asana, Mailchimp, CRMs like Insightly and Capsule and more. Cost: Free for 5 Zaps then discounted by 15% if you are a charity.[sourced from <http://dogoodjobs.co.nz/tools-of-the-do-good-trade/>]

### **Police Vetting Latest Update:**

The Vetting Service secure website has been updated to allow all Approved Agencies to prepare for Cost Recovery by entering billing and charity information. From 1 May 2017 eligible Approved Agencies will be able to apply for waivers. The application forms will be located on the Vetting Service website under the '[Cost Recovery](#)' section from 1 May 2017.

In line with this and to reflect minor changes since their inception, the Approved Agency Agreement (AAA) and Offshore Approved Agency Arrangement (OAAA) documents have been updated. All agencies will need to resign them before **30 June 2017** to enable vetting requests to be submitted. These documents can be resigned electronically via the vetting website. You will be prompted to do this when you login.

### **Who are a charity's officers?**

The Charities Act 2005 may define officers differently to the way your rules define them. An officer can be a person or a body corporate. If your charity is a trust, your officers are all your current trustees.

If your charity is **not** a trust, your officers are:

- all the members of your highest governing body (e.g. committee, board, etc.), and
- all the people in a position to have significant influence over your management or administration (for example a chief executive or a chief financial officer).
